4. FIRST AID MEASURE

GENERAL INFORMATION

Remove affected person from source of contamination. Perform artificial respiration if breathing has stopped.

NOTES TO PHYSICIAN

INHALATION

Inhalation may cause coughing, tightness of the chest and irritation of the respiratory system. Move the exposed person to fresh air at once. Get medical attention if discomfort continues.

INGESTION

5. FIRE FIGHTING EXTINGUISHING MEASURES

SPECIAL FIRE FIGHTING PROCEDURES.
